



Enrollment Agreement 2018 - 2019 Academic Year

Far Horizons Montessori School, agrees to enroll the child named below for the 2018 -2019 academic year. In consideration of the acceptance of this Enrollment Agreement by Far Horizons Montessori School, the undersigned agrees to pay all required tuition and fees charged by the school for the entire academic year and to comply with the following terms and conditions:

1. **Registration Fee** – In order to secure a space for my child at Far Horizons Montessori School, this signed agreement and a non-refundable registration fee shall be submitted to the school with the 2018 -2019 student application /enrollment form. This agreement shall become valid only upon payment in full of past-due fees and tuition from any prior school year. I understand that the registration fee is due and payable with this enrollment agreement.
2. **Payment Plan** – I agree to pay the tuition and fees for my child according to the payment plan designated below (Please check your option.)

_____ Plan 1: **Annual Tuition**– (discounted) annual tuition & fees due June 1, 2018

_____ Plan 2: **Ten Monthly Payments** - annual tuition paid in ten equal monthly payments due August 1, 2018 - May 1, 2019

3. If enrollment occurs after the academic year has begun, the tuition shall be for the remainder of the school year and shall be calculated as a proportion of the full year's tuition commencing from the first day of the month in which the student enrolls.
4. **Effective date of agreement** – This agreement shall be effective only upon signature of a parent or legal guardian and the receipt and acceptance of the contract by the school. Enrollment as specified within this Enrollment Agreement may be canceled by the parents or guardians in writing, without penalty (except forfeiture of registration fees) prior to May 1, 2018. After April 30, 2018 this agreement may not be canceled, and the full annual tuition becomes due unconditionally. No portion of outstanding charges will be refunded or canceled.
5. **Tuition and Fees** – Tuition and fees will be charged according to the current Tuition and Fees Schedule which may be adjusted on an annual basis by the school. By signing below, I acknowledge having received the Tuition and Fees Schedule for the current school year. I understand that if the parent or guardian, fail to pay any payment when due, the school reserves the right to require that all future tuition and fees be paid in advance. There will be a \$45 charge for any check returned to the school by the bank. If the parent or guardian defaults on any payment or other obligation under this agreement, the school reserves the right to refuse to admit the child to class. Any payment not paid when due shall be subject to a \$25.00 late charge per month. I agree to pay all attorneys, court, legal fees and all other collection charges incurred by the school to collect any tuition or fees.
6. **Rules and Regulations** – I agree to comply with the schools rules, regulations, and policies, as may be amended from time to time, including but not limited to, those set forth in the Parent Handbook as adopted by the school.
